



Training Program Award

Important Dates

Training: November 15, 2006 – February 15, 2007

Entry Dates: November 16, 2006 – February 22, 2006

Selection of winners: February 28, 2006

Travel Dates: Spring 2007

Steps

- DFZ Rep submits a complete entry form for each store visited on a monthly basis, listing all HD employees that were trained and the total amount of points earned for that store.
- All points will be accumulated through February 15. At that time, the number of accumulated points will be divided by the number of store serviced by each individual rep.

Point System

Existing Associate: 5 points

New Associate*: 10 points

*New associates can only be listed once. If retrained during a different month, they may qualify as points for "Existing Associate" (5).

Guidelines

1. Distributor Representatives are asked to visit their respective stores and train all new and existing associates.
2. Once a training class is completed, Distributor Reps should complete a registration form for each store and fax it to 713-960-0012. The more Associates each HD Rep trains and the frequency, the more points that will be earned.
3. All entries submitted will be verified for accuracy. If the information submitted is accurate and verifiable, all of the entries for that Rep will qualify for the drawing.
4. Travel arrangements will be coordinated in full by Cosentino USA. Reward includes airfare, meals and accommodations. Cosentino will not reimburse the DFZ for the time the employee spends on the trip. Cosentino reserves the right to make any changes to the award program without previous notice.
5. Trip reward may not be issued if an employee is not available to travel during the travel dates as specified by Cosentino. It is the recipients responsibility to ensure they have the proper documentation to travel overseas.
6. This is an individual employee reward that is not transferable. DFZ employers may not choose who the recipients of the reward is if someone from their company wins.
